Standard Operating Procedure (SOP) for admission of Working Professional into Third Semester(Lateral Entry) of AICTE approved Diploma / Degree Courses in Polytechnics and Engineering collegesaffiliated to JUT, Ranchiwith effect from academic year – 2023-24:

1. Admission Procedure:-

Process A-The state admission authority, Jharkhand Combined Entrance Competitive Examination Board (JCECEB) Ranchi, will invite Institute wise applications with prescribed application fee from the eligible working professionals by giving advertisement in Hindi and English daily newspapers. After scrutiny of applications, Board will prepare the common and category merit list on the basis of % of marks obtained in the qualifying examination for each of the approved courses of the institute. Thereafter the Board will publish the list of institutes and its branch wise shortlisted eligible working professionals followed by issuance of seat allotment letter as per seat matrix provided by Directorate of Technical Education which can be downloaded from website for admission in respective institute. The Board will collect from the institutions the branch wise vacancy position after the prescribed last admission date and issue the 2nd list recommended working professionals for second round of admission.

Process B -After completion of two rounds of admission process by JCECEB if the approved intake seats remain vacant, in that case the concerned private or institute running under PPP mode will advertise their vacancy position and will invite the application form from the eligible working professionals and vacancy shall be filled up through open counselling at institute level in presence of Departmental (DHTE, GOJ, Ranchi) and University (JUT, Ranchi) representative. The process of admission shall be completed entirely on the basis of merit list of qualifying examination score. All vacancy will be filled irrespective of category criteria but the restriction of location of working industry/organization/company within 50 kms from Institute will be strictly observed. The list of admitted working professional through this process shall be signed jointly by Departmental representative,

JUT representative and Head of the institution and it would be positively submitted to Directorate of Technical education and its copy shall be made available to JUT within the time limit fixed by the Directorate of Technical Education.

Note - The both process of admission shall be completed within the cut off date prescribed by AICTE.

Note 1-University (JUT) will prescribe the subjects such as Engineering Mathematics, Engineering Drawing etc. for the working professional coming from diverse background.

- 2- 80% of seats shall be filled by working professionals having passed 10+ 2 Years ITI engineering trade/+2 Vocational (2 Year Course in any engineering trades) under Lateral entry in any approved discipline of Diploma Engineering/Technology. For the rest 20% seats +2 Passed 10+2 Examination Science with PCM are eligible under Lateral entry in Diploma Engineering/Technology Program. In case of vacancy the seats may be filled up from other category and vice-versa as the case may be.
- 3 80% of seats shall be filled by passed Minimum 3-years / 2years (Lateral Entry) Diploma under Lateral entry in any approved discipline of Engineering Colleges. For the rest 20% seats passed B.Sc. Degree from recognized University as defined by UGC are eligible under Lateral entry in Diploma Engineering/Technology Program for Engineering colleges. In case of vacancy the seats may be filled up from other category and vice-versa as the case may be.

3. Eligibility criteria of Working Professional for Admission(other than Academic)

- **A.** Registeredindustry/Organization (Central/State) Private/Public Limited Company/MSMEs where the Working Professional is posted/working must be located within 50Km radial distance from the institute.
- **B.** The Working Professional should have minimum 3 Years of Full time/Regular working Experience.
- C. The Working Professional should not be working in the evening or night shift in case of industries.
- **D.** The Working Professional shall produce No Objection Certificate (NOC) and Character / Conduct certificate issued for the admission in the particular session by the any of authority mentioned below (as the case may be)
 - Central/State PSU- GM (P)/ Executive Director (P)/ Chief Finance Officer.
 - State Government Organizations- Chief Engineer/ Chief Executive Officer/ Managing Director.
 - MSMEs/ Reputed Private Sector MD/ GM/ Key Managerial(P)
- E. There shall not be minimum age for admission of working professional but the maximum age should not be more than 55 years.
- **F.** The working professional should not be facing or faced any departmental enquiry or proceeding of any charges or ever prosecuted or punished by any court or tribunal meaning thereby he or she should have neat and clean service career record since joining.

4. Industry/Organization (Central/State) Private/Public

Company/MSMEs

A. For Private Companies there should not be any case of transgression or litigation history with the Central/ State Government.

B. The Industry/Organization (Central / State) should have positive net worth for last 3 consecutive years.

- C. The Private Company & MSMEs should be a reputed company and it should have valid registration with competent authority/Udyam Certificate (in case of MSME) on the date of issue of NOCs to its regular working employee for admission.
- D. A Maximum of five(05) NOCs shall be issued per academic year by any of the Industry/Organization (Central/State) Private/Public Limited Company/MSMEs.
- E. Incase of Private / Public Limited Company there shall be minimum 25 number of working employees. The company should be of at least 5 years old with average annual turnover of 5 Cr. in last 3 consecutive years.

5. Domicile/Reservation

The Working Professional shall have to submit permanent or local residential and cast certificate issued by not below the Rank of Circle Officer in the latest proforma notified by Personal, Administrative and Raj bhasha Department, Govt. of Jharkhand in order to get the benefit of prevailing reservation policy of the State. Failing to this, the working professional shall be treated under GENERAL or UNRESERVED category.

Seat Matrix

The Directorate of Technical Education will provide institution and branch wise seat matrix to the state admission authority (JCECE Board) as per prevailing state reservation policy and the terms and conditions of concession agreement signed by Governmentin case of polytechnics or engineering colleges running on PPP Mode.

Fee & Other Charges

A. The State Fee Fixation Committee shall decide and notify the fee and other charges for the Working Professionals taking admission to different AICTE approved Diploma or Degree institutions.

B. In case of Government Polytechnics/Government Women's Polytechnics / Government Engineering colleges, the fee and other charges shall be decided and notified by the Department of Higher and Technical Education.

C. In absence of a fresh notification related to fee and other charges for the admission of Working Professionals to a diploma institute or the degree engineering college, the fee and other charges notified earlier for the candidates getting admission through Lateral Entry either in respective polytechnic or engineering colleges may be charged and after fixation and notification of new fee structure for an institute by the state fee fixation committee separately for working professional, the excess or shortage in the fee and other chargesshall be adjusted or charged extra(as the case may)from admitted working professional during deposit of next semester fee.

9. Requirement of Diploma/Degree level institute for admission of working professionals

- A. Proper and valid AICTE approval.
- B. Valid affiliation of the courses by JUT, Ranchi.
- C. At least 1/3 admission of the approved intake is essential to run the course in a particular academic year.
- D. Maximum 3 courses with intake capacity of 30 in each shall be permitted per institute.
- E. The institute shall have sufficient Faculty, Technical & Supporting office staffs to conduct the classes in the evening hours or any flexible convening timing in alignment with timings of industry/Organization.
- F. There shall be 40% of credit transfer through MOOCs/SWAYAM. So, the Institutions should be capable of providing proper facilities for it.
- G. Existing Faculty in the institute / industry Experts as per AICTE Norms shall be permitted with additional remuneration/ honorarium as per the state Government/DTE/University directives.
- H. Existing staff (Technical/Supporting) shall also be permitted with additional remuneration / honorarium as per the State Government/DTE/University directives.
- 1. The institute should have Zero Deficiency Report generated from AICTE web portal for the academic year in which admission is permitted.
