2. Vision

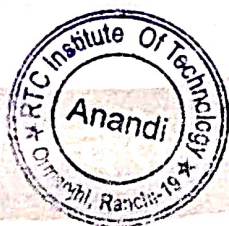
To create a safe, inclusive, equitable, and empowering campus environment for SC/ST students and staff.

- Review welfare initiatives and support measures

B. Grievance

- Receive complaints of caste discrimination, harassment, bias, exclusion, or denial of facilities
- Conduct confidential and impartial inquiry
- Recommend corrective / disciplinary action

C. Monitoring

- Review scholarship outreach and beneficiary access
- Monitor academic progression and retention
- Identify barriers affecting students

D. Reporting

- Submit semester/annual report to Principal

Complaint Redressal Procedure

- Acknowledgement within 3 working days
- Preliminary review within 7 working days
- Inquiry if required
- Recommendation within 30 working days

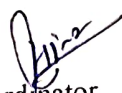

Support Measures for Students

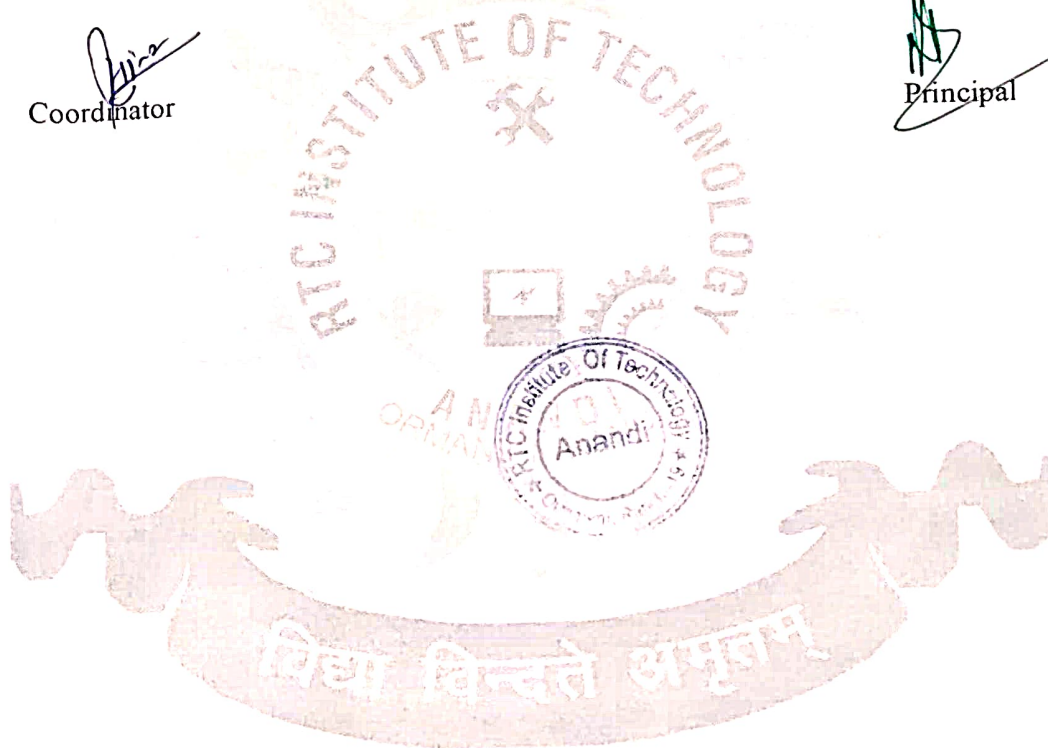
- Remedial coaching
